b. Fiscal Year 2024-2025 Final Budget

Chair Muchovej opened the item and turned it over to Assistant Administrator Bullis.

Bullis reviewed the item with the Board.

Chair Muchovej asked if there will be costs associated with LAFCO for changing the jurisdictional boundary of the land parcel. Authority Administrator Gamino explained that the bulk of the cost would be charged to staff time and under the Professional / Technical line item, there is \$25,000 for undefined expenses that could be used.

No public comment was received.

Vice Chair Schwartz made a motion to approve the 2024-2025 Final Budget and Board Member Pachucki seconded the motion. Motion approved 4-0.

STAFF AND BOARD REPORTS

Vice Chair Muchovej opened the item and asked for reports from the Board.

Muchovej asked what the Board could do to address what can be perceived as degradation in the spirit of a collaboration. Muchovej explained that he attended a recent Eastern Sierra Community Service District (ESCSD) Board meeting and was caught off guard that there was an agenda item on Tribal discussion after the BAWA Board agreed to wait until more background information was received before sharing with the ESCSD Board and the City of Bishop City Council.

Board Member Stone disagreed with Muchovej and recalled Pachucki bringing up the topic in a recent BAWA Board meeting. Muchovej pointed out in the minutes approved in item 5 where it mentioned waiting for background information.

Pachucki said that it was the ESCSD's intent to initiate discussion related to pros and cons.

Muchovej suggested all board members keep each other better informed. Pachucki added that part of open discussion is also at staff level and Gamino is working with the District to schedule a meeting with staff. Gamino confirmed that the plan is to start scheduling bi-monthly meetings to discuss what is going on jointly in the sewer system.

No further reports were made.
